- A copy of the LASD Video on the subject of "Deputy Cliques" which Sheriff Villanueva stated had been transmitted to the Civilian Oversight Commission during the Commission Meeting on January 21, 2021. Included please provide any documents transmitted by or to LASD related to the transmittal of the video.

- COVID-19 Outbreak Line List for Corrections, for the period of March-December 2020, such as the **completed forms located at <http://publichealth.lacounty.gov/acd/nCorona2019/B73COVID/Corrections/index.htm>** under "Forms/Quick Links" (See http://publichealth.lacounty.gov/acd/Diseases/EpiForms/COVID_CorrectionsOBLineList.xlsx).
