Pursuant to the California Government Code 6254(f) "Public Records Act", we do not release crime reports to the suspect or their representative. Release of traffic collision/accident reports is restricted to those specifically authorized under the California Vehicle Code Section 20012 et al.

The search results may include a response that there is no reportable record, a record existed but its details have been purged, or that the record was identified to be an incident within another agency's jurisdiction. BOOKING INFORMATION

Other terms used for this service: "booking record", "arrest disposition information", "in-out dates", "incarceration record", or "proof of jail time". This service involves a search of internal systems using information provided by the client such as a name, date of birth, and/or booking number. The results are then reported on our agency's letterhead. Clients requesting this type of service are asked by the requestor to provide proof of release from custody for benefits re-instatement, disposition of arrest for licensing, immigration, or employment purposes, for example. Please note that this search is based upon the information provided by the client and the search results will indicate what was located, even if the client has an alias name as a search result.

An additional copy of a letter response will be charged a fee of \$4.00 per copy.

This service involves a search of internal systems using the person's name and date of birth only and not based upon a search of fingerprints. The results are then reported on our agency's letterhead. Clients requesting this type of service are generally asked by the requestor to provide proof that they do not have a record for immigration purposes, employment, licensing or adoption purposes, etcetera. Please note that this search is not based upon fingerprints.	\$ 35	An additional copy of a letter response will be charged a fee of \$4.00 per copy.
BOOKING PHOTOGRAPH	Booking photographs are considered to be a part of a suspect's criminal history information and release is dependent upon the California Penal Code Section 13300 et al. Release to Bail Bonds Agents is dependent upon the standards set forth under Section 11105.6 of the California Penal Code. Valid identification and proof of status as Bail Bonds agent is required.	\$ 16	
FINGERPRINTING "LIVE SCAN"	Our Public Counter has the California Department of Justice Live Scan machines available to clients requiring fingerprints to be electronically submitted to the California Department of Justice (DOJ) and/or Federal Bureau of Investigation (FBI). Personal record review forms will be provided; however, clients are responsible for bringing in a DOJ Live Scan <u>form from the requesting agency</u> , which clearly indicates the type of service they are requesting, such as for employment, licensing, or certification. If there is no billing code provided by the agency requesting the Live Scan, you will be responsible for paying the fees charged by DOJ and/or FBI, in addition to our service fee. We do not provide manual fingerprint card services. We also do not receive the results of any DOJ or FBI submissions here at our location; the results are sent directly to the requesting agency or requestor. *Please note that the California Department of Justice may have other fees associated with the type of service requested in addition to the fees specified below:
