OUTREACH

On June 3, 2022, at approximately 10:00 am, Ms. [REDACTED] and her attorney met with the LASD Homicide Bureau. The meeting took place at Homicide Bureau, [REDACTED], California. The investigating detectives were present to answer her questions and made associated evidence accessible.
