The Civilian Oversight Commission (COC) is committed to serving as a critical advisory body to the Los Angeles County Sheriff's Department (LASD) including working to advance transparency, accountability, and to improve communications between the LASD and the communities it serves. The LASD has made an effort to ensure that the LASD Public Data Sharing website consists of 2018 Custody Division reports. However, there are several reports that the LASD previously made available to the public on this webpage that have yet to be updated.

On behalf of the Civilian Oversight Commission (COC), I am requesting the LASD make available to the public on the LASD public website 2018 and 2019 versions of the following reports or their replacement reports as these reports were previously made available to the public in addition to the Custody Division reports:

1. Field Reports for each Patrol Division
2. Court Services Division Reports
3. Countywide Services Reports
4. Transit Policing Division Reports

I would further request that the above materials be consistently made available to the public on the LASD public website from this point forward unless there is a specific reason not to do so. If there is a specific reason not to place all or a portion of these materials on the public website provide the COC with the reasons for not publicly displaying all or parts of the materials on the LASD website and similarly note such reasons on the public webpage.

Fulfillment of this request will enable COC to continue to function as a bridge between LASD and the community, and further strengthen the level of transparency between the LASD and the community.

Please provide a response to the above request by **December 23, 2019**.
