07/26/22	Narcotics Bureau	Non-Hit Shooting	N/A	A plainclothes deputy wearing a tactical vest was sitting in an unmarked vehicle when the suspect approached him. The suspect pointed a firearm at the deputy. The deputy exited his vehicle and a deputy involved shooting occurred.
08/16/22	Compton Station	Hit Shooting	Wounded	Deputies responded to a domestic disturbance. Upon their arrival, a woman fled the residence towards the deputies. The male suspect stood on the front porch and shot at both her and the deputies with a firearm. A deputy involved shooting occurred.
08/31/22	Century Station	Hit Shooting	Deceased	Deputies were called to the location regarding a man swinging a machete. Deputies contacted the suspect and he charged towards them with the weapon. A deputy involved shooting occurred.
09/02/22	South Los Angeles Station	Hit Shooting	Deceased	Deputies were called to the location regarding a intoxicated man with a gun. As deputies were speaking with an individual at the scene, the suspect appeared and pointed a firearm at them. A deputy involved shooting occurred.
09/05/22	Lancaster Station	Hit Shooting	Wounded	Deputies detained a possible robbery suspect. During the detention, the suspect pointed a firearm at the deputies. A deputy involved shooting occurred.
09/21/22	Century Station	Hit-Shooting	Wounded	Deputies responded to the location regarding a man brandishing a firearm at people. Upon their arrival they saw the suspect who immediately pointed a firearm at them. A deputy involved shooting occurred.

09/26/22	Norwalk Station	40mm projectile to abdomen and thigh	The inmate was hospitalized for rhabdomyolysis. A 40mm baton launcher was used on the suspect after he started a fire in his parent's home and refused commands to exit.

07/17/22	Men's Central Jail	Jail cell key to head	Inmate punched deputies during an escort. Deputies returned punches while holding a jail cell key.
07/25/22	Men's Central Jail	Pepperball projectile to face	Deputies deployed a pepperball launcher in response to a dorm fight. One inmate was struck on the face.
