### **Mission Statement**

The Palmdale Sheriff's Station Community Advisory Committee (CAC) was established in 2011 to promote a better understanding between the public and the Los Angeles Sheriff's Department (LASD). It was created to build trust and promote dialogue between local law enforcement, the community and advocate for justice and equality.

The CAC functions to bring concerns and issues from the community to the Sheriff's Department to address those concerns, establishing a partnership with the local community in the process. Additionally, the Sheriff's Department benefits from this two-way dialogue by gaining a greater understanding of the issues of concern in the communities they serve.

### The CAC is authorized to:

- 1. Advise the Sheriff and the station commander on strategies and training to improve community relations, bias-free policing, and access to the civilian complaint system.
- 2. Work with the Sheriff and station commanders to establish and carry out community public safety priorities.
- 3. Provide the community with the information on the Settlement Agreement and its implementation in English and Spanish; and
- 4. Receive and convey to LASD public comments and concerns.

The CAC is composed of community members who volunteer their time to act as a representative of various constituencies. Committee members are not employed by the Sheriff's Department and do not receive any compensation for their time. The CAC produces regular Annual Reports which are posted on the LASD website.

### **Committee Structure and Responsibilities**

The Palmdale CAC formally established an administrative structure to assist the Sheriff's Department more efficiently in their collaboration and dialogue with our local communities. The Palmdale CAC should be comprised of at least seven civilian representatives of the community. Reasonable efforts will be made to maintain an odd number of members to achieve a majority decision should the committee need to vote on a report or recommendation.

### Chairperson

The Chairperson acts as the committee's leader and ensures they function as a team. The Chairperson does not run the committee but spends time considering all assignments to make sure that all the work of the committee is effectively delegated for completion. The Chairperson conducts the monthly meeting.

### Vice-Chairperson

The Vice-Chairperson assists the Chairperson in executing the committee's mission and takes over the functions of the Chairperson when absent, in addition to other functions and duties required by the committee.

### Secretary

The Secretary records the minutes of the committee and maintains all correspondence, both internally among the board members and externally with public organizations. The secretary attends to all correspondence of the organization. Additional duties may include issuing notices of meetings, preparing the agenda and other documents for the committee.

### Station Liaison

The Station Liaison is the liaison to the DOJ Monitoring Team and coordinates the dissemination of all committee information to public venues, including publicity for upcoming Town Halls and public meetings. The Liaison may also respond to questions and concerns from the community that are directed to the Committee.

### **Activities Coordinator**

The Activities Coordinator informs the committee about current and potential opportunities for the CAC to engage with the community, such as Days of Dialogue, Open House, and other community events.

### **Social Media Coordinator**

The Social Media Coordinator maintains and updates the various social media platforms available to the CAC. The CAC has both a Facebook page and Instagram page. As other platforms are made available to the CAC, this will be an added responsibility of the Social Media Coordinator.

### Youth Representative

The Youth Representative informs the committee about current and potential opportunities for the CAC to engage with the youth of the community, such as Teen Summit, school functions, and other youth related community events.

### **Administrative Appointment Terms:**

- CAC board members shall serve for a term of two years or until their successors are elected. All members have the right to re-apply for renewal of her/his position with no term limit to serve. (In the event that no successor is elected, the position is declared vacant.)
- The two-year term begins on July 1 of the elected year and continues through June 30 two years later.

### **Committee Composition:**

- The committee shall not exceed thirteen members and all efforts will be made to maintain an odd number of members to achieve a majority decision.
- New board members can only be appointed by a mutual approval of the CAC majority vote and approval by the Palmdale Sheriff's Station Captain.
- All positions will be evaluated every year and the committee can determine any additional offices and/or reappointments by majority consensus.

### **Meetings:**

The Palmdale CAC shall meet monthly, although meetings may occur more frequently if deemed appropriate. Any meeting with two or more board members during the month will be considered an official meeting and satisfy the requirements of having a monthly meeting required by the Department of Justice Settlement Agreement.

### Quorum:

A Quorum will be established with the presence of half the committee plus one in attendance.

### Voting:

A majority consensus will determine the decisions made by the committee.

Lilia serves as a member Community Advisory Commission of the LA County Sheriff Department, Palmdale Station since its inception.

### Bishop Henry Hearns - Member at large

The Mississippi native has lived in the Antelope Valley for approximately 55 years and has been actively involved in his community from his arrival to present. Bishop Hearns is a rare breed as he retired from three major positions: He is Pastor-Emeritus of Living Stone Cathedral, which he served for over 51 years, retired as Chief of Environmental Engineering from EAFB for over 32 years, and he is Mayor-Emeritus for the City of Lancaster, after 18 years of service.

Community concerns and resolutions discussed at Monthly CAC Meetings during reporting period January 1, 2022 and December 31 2022:

### 1/24/22- CAC Board Meeting

• Cancelled in favor or January Town Hall meeting.

### 2/7/22 CAC Board Meeting

### A) Monthly Citizen Complaints with Demographics

The combined number of monthly complaints for January are as follows: 4 complaints and 6 commendations. Unfortunately, no demographics were provided. Types of complaints filed were as follows: 3 discourtesy complaints and 1 service complaint. The station continues to focus on de-escalation and conflict resolution between the parties' making complaints and the deputies.

Captain was hoping to find an organization that can help in conflict resolution; Kamal referred him to an organization called CALM.

### B) Community Concerns

Discussed Off Highway Vehicles and the benefit of OHV stops to deterring crime in their community. Marcy proposed that CAC write a letter to the Board of Supervisors to request funding for OHV stops in unincorporated areas of LA County. All agreed, Marcy will write the letter and bring to the next meeting for review.

### 3/14/22 CAC Board Meeting:

### A) Captain's Update Report

The Risk Management Forum will be held March 24<sup>th</sup>, the goal is to discuss findings at the next meeting in April. There are staffing issues within the department and the county, which continue to be very challenging overall. Personnel are leaving the department, not just retiring, they are leaving at the beginning of their career and are also leaving the state. There will be a lot more movement soon and there is hope that with upcoming promotions, new personal will be added to the station.

Captain debriefed and discussed the critical incident, deputy involved shooting, that occurred March 13<sup>th</sup> in the city of Palmdale. Homicide is investigating and when it is complete more can be discussed.

### B) Monthly Complaints with Demographics

Eleven service comment reports were submitted in the month of February. Eight of those were commendations regarding interaction with the public and three were complaints. Of those compliant reports two were regarding force and one was an off-duty conduct complaint. Unfortunately, no demographics were provided.

### C) Community Concerns

Marcy C discussed the current Acton Town Council Meeting. She advised that the community members are very thankful for all the grow house busts that have been occurring. She also mentioned a new concern regarding a film house that has been creating a buzz within the community. The community is having issues with the bright lights and excessive noise during various times of the day.

### 4/7/22 CAC Board Meeting

### A) Captain's Update Report

It has been a busy week in Palmdale. There were a few traffic fatalities: auto vs. pedestrian, person in roadway – hit and run, and a two-vehicle collision. Traffic continues to be a huge issue for the city as well as intoxicated drivers. The Palmdale Station is working with Lancaster Station and CHP to do speed checks and DUI saturation. Deputies also attended schools and gave presentations on distracted driving. Other incidents that occurred this past week were a barricaded suspect and bomb threats/active shooter threats occurring at Palmdale Aerospace Academy. Captain briefed the committee on these incidents.

Part 1 crimes are up 13% compared to this same time last year. There is an increase in thefts, burglaries, and grand theft of autos. This year this far there have been four homicides versus a total of 10 for the year of 2021. Three out of the four homicides were gang related. Despite the increase in crime deputies are still out there and dedicated to their duties.

### B) Monthly Complaints with Demographics

Twelve service comment reports were submitted in the month of March. Three of those were commendations and nine were complaints. Of those compliant reports one was a service complaint and eight were personnel complaints which can include multiple items. Items that were brought up were as follows: five discourtesies, two neglect of duty, one off duty incident, one improper search and detention, one unreasonable force and one discrimination complaint. All items are being examined and being discussed. There is a disconnect regarding the program and the report where demographics aren't being populated.

### C) Community Concerns

Marcy C briefed the committee regarding Off Highway Vehicle issues in her community. She advised that the issue has been escalated and taken to Parks as well as the Board of Supervisors.

### 5/9/22 CAC Board Meeting

### A) Captain's Update Report

Crime trends are up seventeen percent compared to last year. The is related to an increase in homicides, thefts, and arsons. There are ongoing issues such as domestic violence, gangs, mental health, and homelessness that attribute to these crimes.

### B) Monthly Complaints with Demographics

There were thirteen service comment reports in April. Seven of those reports were commendations and six of them were complaints. Of the complaints five were personnel issues and one was regarding policies and procedures. No known demographics were provided.

### C) Community Concerns

Captain provided briefing regarding the Off Highway Vehicle issues in Acton/Agua Dulce.

### 6/13/22 CAC Board Meeting:

### A) Captain's Update Report

Crime trends are up twenty-three and a half percent compared to last year. This is related to a multitude of incidents including but not limited to homicides, thefts, aggravated assaults, and grand theft autos. Ongoing issues such as domestic violence, gangs, mental health, and homelessness also attribute to these crimes.

### B) Monthly Complaints with Demographics

There were nineteen service comment reports in May. Six of those reports were commendations and thirteen of them were complaints. Of the complaints eleven were personnel issues and two were regarding policies and procedures. No known demographics were provided.

### C) Community Concerns

Glenn: Littlerock is having issues with speeding by Dominic Massari Park as well as response times for calls made deputies are taking too long to respond. Also, transient issue near Walmart; increase of theft and mess left on the streets.

Kamal: There is a transient issue near the mosque; occupying area and using utilities.

Chad: Issue with transient performing lewd acts in public at 861 Auto Center Drive.

### 7/11/22 CAC Board Meeting

Report from Capt. Shafer deferred till next month's meeting due to captain's absence.

- Lillia expressed concern regarding why the DOJ report was not reviewed during the July town hall meeting.
- Lt. Dantice reminded her that the seconds DOJ report for 2022 will released in the next few days.

 The LA County Sheriff's Department DOJ policy team will review next week prior to releasing to public. Lt. Dantice suggested that CAC team can review the DOJ report at the August 2022 Board Meeting.

### Monthly complaint report:

- Deferred until next month due to captain Shaffer's absence
- Kamal A
  - Community activist Marco Alvarez called Kamal to report a complaint stemming from an incident that occurred on weekend of 6/24 at the 4 Points Swap Meet. An individual with developmental delays or mental health issues was denied access to the Swap Meet and a disturbance occurred. Deputies responded. Lt. Dantice will pull up the call log and look into the incident.
  - o Kamal expressed concerns regarding an ongoing incident where an unhoused individual has been breaking into the utility room at the local Mosque located at 1125 E. Palmdale Blvd. Palmdale CA 93550. Lt. Dantice will make sure the PM shift is notified so patrol deputies can keep an eye out. Sgt. Amis has been looking into it and will follow up with Kamal.

### 8/8/22 CAC Board Meeting

### Monthly complaint report:

- Capt. Shaffer provided updates on the # of citizen complaints during the month of July.
- Meeting participants discussed complaint process. Lilia discussed ways to use her radio program as a way to inform the public about how to contact station leadership if they have a concern.

Lilia agreed to interview Lt. Dantice on her program as a tool for helping community members get to know Palmdale station leadership.

### 9/12/22 CAC Board Meeting:

- Discussion about how to document the great work that the Palmdale CAC is doing.
   Team members expressed concern that the most recent DOJ report was overwhelming negative regarding the work of the CAC.
- Kamala and Sgt. Amis discussed arrest of shooting suspect that Kamal and members of his Mosque provided information to Det. Munoz that led to suspect's arrest.
  - Sgt. Amis and Kamal will meet to discuss ways to capture success stories like this for future DOJ reports.
- 2020 Use of Force report will be released shortly and may contain demographic data that may answer some of the questions regarding demographics of individuals involved in use of force incidents as well as regarding complaints filed.

### 10/11/22 CAC Board Meeting

### Capt. Report

- July, Aug, and Sept 2022 Sgt. Amis let CAC know that there is no way to provide demographics about the persons filing complaints.
- Cat 1 = 11 re: Employees
  - o 5 Neglect of duty (All cleared)
  - o 1 Discrimination (Under investigation)
  - o 1 Discourtesy (Cleared)
  - o 4 Improper detentions
- Cat 2 =: Service Complaints # not captured by note taker
- Commendations = 3
- 2020 Force Report under development and is modeled on LAPD and Seattle PD and may include #'s from 2018 and 2019
  - Use of force policy is under review.
    - Main sticking point is DOJ request that a \*438 report be filled out every time a Deputy point a firearm at a citizen
  - LASD working on a tracking system so deputies can articulate justification for pointing firearm at a citizen.
  - Goal to track statistics about overall # of complaints.
- Sgt Amis shared the workforce allocated at the county to work on the DOJ Compliance project is
  - o 2 DOJ Contract deputies
  - o 2 DOJ Contract Sqt.'s
  - o 3 Lt.'s
- Kamal requested data regarding complaint trends over the past 3 years to present at CAC quarterly meeting.
- Lilia voiced concern that there is no data tracking the ethnicity of complainants.
  - Sgt. Amis shared that this data is not collected on complaint form but shared that ethnicity is tracked in STOPS data.
  - o Of 1947 traffic stops:
    - 24% of all traffic stops involved a black driver, 12% of AV population is black according to census data
    - 57% of traffic stops involved Hispanic driver. 59% of AV population is Hispanic according to census data.
    - 15% of traffic stops involved a white driver, 19% of the AV population is white according to census data.

### Community concerns:

Graffiti is "Out of control". Mike Miller shared Palmdale city program issues that have affected clean-up efforts such as funding for graffiti abatement funding, as well as Youth Build program during pandemic being halted.

- Lowes has been fined multiple times for not locking their paint cages.
- There is an RFP out to Victory Outreach to do clean up.

- Issues such as illegal dumping have taken up city resources.
- Confusion from property owners about it being their own responsibility to paint over graffiti if their property is vandalized.
- City has funded a graffiti cleanup truck.
- The bail schedule for graffiti has changed so now it is a misdemeanor and prosecution is not pursued.

### 11/21/22 CAC Board Meeting:

### Capt. Report

- Sheriff Villanueva conceded election to Luna who will be sworn in on 12/5/22.
- ALAD and POPA union's role discussed briefly in LA county law enforcement.
- Discussions surrounding LASD mood on the ground with change in leadership.
- Discussions surrounding Sheriff Villanueva's leadership approach when he took office and experience leading such a large bureaucracy.
  - Discussion surrounding size of LASD vs. LBPD and task of getting to know a department as large as LASD with over 4K mile service area.
  - o Luna has announced his transition team.
  - Next LASD election is in alignment with 2028 presidential election.
  - 30% down in sworn positions county wide so deputies work +- 120 hrs. of mandatory OT each month
  - Board of Sup. Approved 3 additional academy classes but that will not be enough to catch up
  - +-300 custody staff currently requesting transfers.
  - o 300-400 additional will be lost this year due to retirement and attrition
  - County removed AA requirement for applicants.

### Crime Stats:

- 14% increase YTD in Palmdale which is lower than 16% increase for Lancaster and 17% increase for Santa Clarita
- o 2 fires at Walmart/Target
- o 15 Homicides YTD
- DA's interest in reform is driving current policies which relate to a reduction in the prosecution of criminals
- Palmdale-October had 3 commendations and 15 complaints.
  - o Goal is to sit down with members of the community to problem solve when there is a complaint.
  - o AV Chamber of Commerce parade in Palmdale is a good opportunity

### Community Concerns:

- Robbery in Palmdale with over \$150K in stolen items, with community engagement, LASD was able to sit down with members of the community to collect data for a fast resolution.
- Complains re: theft of coolers.
- Phone Snatching: Good news is that Deputies were able to return the phone within 1 hour.

### **CAC Community Engagement Events:**

### First Responders and Youth AV Community Summit

- Co-organized by members of the CAC, members of the AV Chamber of Commerce and local First Responders such as the LASD, LAFD, CHP, Social Services, Local Mental Health Provider NGO's, local Ambulance companies and Learn for Life charter school.
  - Q&A sessions with first responders, resource fair, emergency response demonstrations and tutorials for teens on how to increase communication and collaboration with first responders including law enforcement.

### Palmdale and Lancaster station Community Academy

### 4/19/22-6/7/22 (Palmdale CAC Vice Chair attended)

50 residents from the Palmdale and Lancaster station areas were able to participate in the Antelope Valley's Forty-Second Community Academy. This program focused on the Sheriff Department's operational procedures, as well as sessions ranging from criminal law to undercover operations. Participants went on a ride-a-long, toured a custody facility and participated in role-playing exercises. The purpose of the Academy was to build a better understanding between the community and the Sheriff's Department through education. The class met for eight weeks and was free.

"Walking with a Purpose" (5/12/22): The event was created through collaboration with the ACLU-AV Chapter, the Dolores Huerta Foundation, the Antelope Valley Wellbeing Coalition, and the Palmdale Sheriff Station. The event brought together members of the community to engage in a neighborhood walk with deputies. This event provided Palmdale residents with the opportunity to establish relationships with deputies directly and engage in constructive dialogue regarding community concerns.

The Dolores Huerta Foundation Halloween Event (10/31/22: This was a community event that brought a diverse segment of the Palmdale community to celebrate Halloween as well as discuss local politics. I utilized this event to promote the CAC as well as to establish relationships and discussions with community members to gain insight into community concerns regarding the Palmdale Sheriff Station. The event saw an attendance level of over 100 individuals.

11/1/22 Palmdale CAC members met with DOJ monitoring team and members of the community at True Life Community Church in Lancaster for a Town Hall meeting for an update on the settlement agreement form the DOJ.

- \*During the 2022 calendar year the Palmdale CAC invited Lancaster CAC members to participate in Palmdale CAC meetings on multiple occasions with the goal to increase communication and share structural and procedural tools for meeting management.
- \*Palmdale CAC invited Nonprofit Organization like Helpers Foundation to work with youth gangs and suppress gang activities in AV.

### \* LASD Palmdale Station Community Engagement Events

- June 26, 2022 was Love my Ride car show, we had approximately 1800 citizens show up for this event on a HOT day 105\*.
- July 26, 2022, was National Night Out, a first responder outing. The response from the community was good many people showed up, approximately 400 residents.
- December 21, 2022. Multiple deputies assisted in driving throughout Palmdale city to hand out toys to needy kids. Approximately 350 kids received toys and two truckloads of toys were handed out.

### Individual CAC Recommendations to Palmdale Sheriff's Department

- 1. <u>CAC members recommended to Captain to have a reach out to Helpers foundation</u>
  <u>that focuses on youth gang activities to suppress gang crimes.</u>
- 2. <u>CAC members recommended to captain to launch a campaign against Graffiti</u>
  <u>crimes in the City of Palmdale.</u>
- 3. CAC members recommended that we keep the number of CAC board members 13 members or less.
- 4. CAC members recommended that we create a new non-voting position called

  Liaison with City of Palmdale; this position is created to facilitate relationship with

  City staff and have no voting rights to avoid possible conflict of interest concerns

  raised by the community when we had City Manager and Assistant City manager

  on the CAC board.

### 5. CAC members recommended to captain that we create a CAC brochure and Operational Handbook Manual.



The station continues its efforts with community-oriented policing and reaching out to the community to find solutions regarding current crime trends. Part one crimes are measured across the nation and are used to compare cities. Compared to January and February of 2021, all crimes have significantly increased. We are showing robbery is up 5%, aggravated assaults up 20%, burglaries up 10%, theft up 38%, and arsons up 6.6%. The only crime the saw a decrease was grand theft, which was down 2.5% to last year.

Kamal: Does CAC contribute to crime reduction?

Response: CAC is not meant to drive crime reduction; it is meant to bring information to light so that the department can address it and find community resources to resolve it.

### B) Monthly Complaints with Demographics

The combined number of monthly complaints for January are as follows: 4 complaints and 6 commendations. Unfortunately, no demographics were provided. Types of complaints filed were as follows: 3 discourtesy complaints and 1 service complaint. The station continues to focus on de-escalation and conflict resolution between the parties' making complaints and the deputies.

Captain was hoping to find an organization that can help in conflict resolution; Kamal referred him to an organization called CALM managed by Linda Hughes in Palmdale.

### C) Community Concerns

Marcy addressed Off Highway Vehicles and the benefit of OHV stops to deterring crime in their community. Marcy proposed that CAC write a letter to the Board of Supervisors to request funding for OHV stops in unincorporated areas of LA County. All agreed, Marcy will write the letter and bring to the next meeting for review.

### D) First Quarter Town Hall Meeting 2022

Members discussed the first quarter town hall that was held at the at Acton Community Center. General feedback was positive.

It has been a busy week in Palmdale. There were a few traffic fatalities: auto vs. pedestrian, person in roadway – hit and run, and a two-vehicle collision. Traffic continues to be a huge issue for the city as well as intoxicated drivers. The Palmdale Station is working with Lancaster Station and CHP to do speed checks and DUI saturation. Deputies also attended schools and gave presentations on distracted driving. Other incidents that occurred this past week were a barricaded suspect and bomb threats/active shooter threats occurring at Palmdale Aerospace Academy. Captain briefed the committee on these incidents.

Part 1 crimes are up 13% compared to this same time last year. There is an increase in thefts, burglaries, and grand theft of autos. This year this far there have been four homicides versus a total of then for the year of 2021. Three out of the four homicides were gang related. Despite the increase in crime deputies are still out there and dedicated to their duties.

### B) Monthly Complaints with Demographics

Twelve service complaint reports were submitted in the month of March. Three of those were commendations and nine were complaints. Of those compliant reports one was a service complaint and eight were personnel complaints which can include multiple items. Items that were brought up were as follows: five discourtesies, two neglect of duty, one off duty incident, one improper search and detention, one unreasonable force and one discrimination complaint. All items are being examined and being discussed. There is a disconnect regarding the program and the report where demographics aren't being populated. Captain will reach out to the unit that generated the report to discuss this issue.

### C) Community Concerns

Marcy briefed the committee regarding Off Highway Vehicle issues in her community. She advised that the issue has been escalated and taken to Parks as well as the Board of Supervisors.







**HANDBOOK** 

The purpose of this handbook is to provide information and direction to members of the Palmdale Community Advisory Committee. The purpose of the Palmdale Community Advisory Committee is to act as a liaison between the public and the Palmdale Sheriff's Station. Nothing in this handbook shall supersede any policy or directive of the Los Angeles County Sheriff's Department, nor shall it contradict the Department of Justice Settlement Agreement. ### **Mission Statement**

The Palmdale Sheriff's Station Community Advisory Committee (CAC) was established in 2011 to promote a better understanding between the public and the Los Angeles Sheriff's Department (LASD). It was created to build trust and promote dialogue between local law enforcement, the community and advocate for justice and equality.

The CAC functions to bring concerns and issues from the community to the Sheriff's Department to address those concerns, establishing a partnership with the local community in the process. Additionally, the Sheriff's Department benefits from this two-way dialogue by gaining a greater understanding of the issues of concern in the communities they serve. The CAC is authorized to:

- 1. Advise the Sheriff and the station commander on strategies and training to improve community relations, bias-free policing, and access to the civilian complaint system.
- 2. Work with the Sheriff and station commanders to establish and carry out community public safety priorities.
- 3. Provide the community with the information on the Settlement Agreement and its implementation in English and Spanish; and
- 4. Receive and convey to LASD public comments and concerns.

The CAC is composed of community members who volunteer their time to act as a representative of various constituencies. Committee members are not employed by the Sheriff's Department and do not receive any compensation for their time as per the terms of the Antelope Valley (AV) Settlement Agreement (2015). The CAC produces regular Annual Reports which are posted on the LASD website.

### **Committee Structure**

The Palmdale CAC formally established an administrative structure to assist the Sheriff's Department more efficiently in their collaboration and dialogue with our local communities. The Palmdale CAC should be comprised of at least seven civilian representatives of the community. Reasonable efforts will be made to maintain an odd number of members to achieve a majority decision should the committee need to vote on a report or recommendation.

### **Duties of Officers**

### Chairperson

The Chairperson acts as the committee's leader and ensures they function as a team. The Chairperson does not run the committee but spends time considering all assignments to make sure that all the work of the committee is effectively delegated for completion. The Chairperson conducts the monthly meeting.

### Vice-Chairperson

The Vice-Chairperson assists the Chairperson in executing the committee's mission and takes over the functions of the Chairperson when absent, in addition to other functions and duties required by the committee.

### Secretary

The Secretary records the minutes of the committee and maintains all correspondence, both internally among the board members and externally with public organizations. The secretary attends to all correspondence of the organization. Additional duties may include issuing notices of meetings, preparing the agenda and other documents for the committee.

### Station Liaison

The Station Liaison is the liaison to the DOJ Monitoring Team and coordinates the dissemination of all committee information to public venues, including publicity for upcoming Town Halls and public meetings. The Liaison may also respond to questions and concerns from the community that are directed to the Committee.

### **Activities Coordinator**

The Activities Coordinator informs the committee about current and potential opportunities for the CAC to engage with the community, such as Days of Dialogue, Open House, and other community events.

### **Social Media Coordinator**

The Social Media Coordinator maintains and updates the various social media platforms available to the CAC. The CAC has both a Facebook page and Instagram page. As other platforms are made available to the CAC, this will be an added responsibility of the Social Media Coordinator.

### Youth Representative

The Youth Representative informs the committee about current and potential opportunities for the CAC to engage with the youth of the community, such as Teen Summit, school functions, and other youth related community events.

### **Administrative Appointment Terms:**

- CAC board members shall serve for a term of two years or until their successors are elected. All members have the right to re-apply for renewal of her/his position with no term limit to serve. (In the event that no successor is elected, the position is declared vacant.)
- The two-year term begins on July 1 of the elected year and continues through June 30 two years later.

### **Committee Composition:**

- The committee shall not exceed thirteen members and all efforts will be made to maintain an odd number of members to achieve a majority decision.
- New board members can only be appointed by a mutual approval of the CAC majority vote and approval by the Palmdale Sheriff's Station Captain.
- All positions will be evaluated every year and the committee can determine any additional offices and/or reappointments by majority consensus.

### **Meetings:**

The Palmdale CAC shall meet monthly, although meetings may occur more frequently if deemed appropriate. Any meeting with two or more board members during the month will be considered an official meeting and satisfy the requirements of having a monthly meeting required by the Department of Justice Settlement Agreement.

### **Quorum:**

A Quorum will be established with the presence of half the committee plus one in attendance.

### **Voting:**

A majority consensus will determine the decisions made by the committee.

### PALMDALE STATION RESPONSE TO CAC RECOMMENDATIONS

The Palmdale Station Community Advisory Committee (CAC) published its annual report. The annual report documented the community engagement efforts of Palmdale Station between January 1, 2022, and December 31, 2022. To help improve the overall relationship between the Sheriff's Department and the community, on page 16 of the CAC's Annual Report, the CAC made the following recommendations to the captain of Palmdale Station:

- 1. CAC members recommended the captain to reach out to the "Helpers" foundation, which focuses on youth gang activities to suppress gang crimes.
- 2. CAC members recommended the captain to launch a campaign against Graffiti crimes in the city of Palmdale.
- 3. CAC members recommended the captain to keep the number of CAC board members to 13 members or less.
- 4. CAC members recommended the captain to create a new non-voting position called "Liaison with City of Palmdale." This position would facilitate the relationship with city staff. This position would have no voting rights to avoid possible conflicts of interest when concerns are raised by the community.

5. CAC members recommended the captain to create a CAC brochure and Operational Handbook Manual.

The purpose of the CAC is to establish partnerships with the community, which includes the youth as required by the AV Settlement Agreement.

Palmdale Station DOJ Compliance Unit / Community Relations has reached out to several youth groups and organizations to assist in reducing gang activity and crimes.

One such activity was the "Teen Summit," where teens were able to voice their concerns to deputies. In this summit, deputies were able to provide the youth in the community information on why School Resource Deputies patrol schools.

Palmdale Station also has the Youth Activities League (YAL) and Vital Intervention and Directional Alternatives (VIDA) programs which are directed toward the community to assist in curbing gang violence. The CAC was reminded they should also be assisting with youth outreach efforts.

Palmdale Station is working with the city of Palmdale on the city-wide issue of graffiti. The city of Palmdale has launched a campaign against graffiti, "Say It, Don't Spray It." This campaign encourages the community to report graffiti incidents and the city assists with the removal of the graffiti.

Palmdale Station has allocated deputies to specifically target the graffiti issue. Their duties are to investigate graffiti, compose incident reports, and arrest those damaging private and city property. The City Attorney is also working with Palmdale Station in prosecuting those arrested for graffiti. Palmdale Station understands graffiti is a quality-of-life issue and is working hard with the city to prevent the destruction of property by graffiti, which commonly is also related to gang activity.

The Palmdale Station DOJ Compliance Unit is working with the CAC and agrees with limiting the number of members allowed on the CAC board. While limiting the number of members to the CAC board, Palmdale Station still wants to work with the members of the community it serves and receive information about the community's issues without limiting the resources.

The CAC has 11 members on the Board; the CAC is encouraged to work with the city to create a non-voting liaison position on its board.

A promotional brochure for the CAC has been the responsibility of each patrol station and the patrol station's CAC. Palmdale Station has created a design with the CAC which was approved and is in the final stages of being printed.
