Subject: **Request for Response to Draft Recommendations and Subject Matter Expert(s) on LASD Psychological Services Bureau**

On April 1, 2025, the Los Angeles County Sheriff Civilian Oversight Commission's (Commission) Ad Hoc Committee on Quality-of-Life (Ad Hoc Committee) met to discuss, among other issues, the final draft of their [report and recommendations on Los Angeles County Sheriff's Department's \(LASD\) Suicide Prevention and Employee Wellness](#). On May 15, 2025, the Ad Hoc Committee draft report will be presented to the full Commission.

To further the mission of the Los Angeles County Sheriff Civilian Oversight Commission, the Commission respectfully requests the LASD:

1. Provide a written response with your agreement or disagreement and any thoughts related to each of the recommendations in the Ad Hoc Committee draft report by no later than May 12, 2025; and
2. Identify an LASD subject matter expert(s) (SMEs) from the Psychological Services Bureau (PSB) to speak at the Commission's Meeting on **Thursday, May 15, 2025, from 9:00a.m. – 1:00p.m.**, at Hall of Records, 320 W. Temple St., Room 160, Los Angeles, California 90012

It would be helpful if the SME could limit their presentation to seven minutes and no more than ten slides discussing the following:

1. LASD's ongoing efforts concerning the provision of psychological services for sworn staff
2. Overview of data related to PSB service provisions for the last year
3. Status of the LASD Wellness Center
4. PSB related policies and procedures

Fulfillment of this request will enable the Commission to better understand the array of psychological services accessible to sworn staff within the LASD. Please kindly respond to this request, **by May 12, 2025**, with a written response to each recommendation in the draft report and the name(s) and contact information for the SMEs who can appear before the Commission on May 15, 2025, to respond to each of the items listed above.
