PARKING ENFORCEMENT DETAIL

The Los Angeles County Sheriff's Department (LASD) Parking Enforcement Detail (PED) provides expeditious vehicle movement using the properly posted signage, curb markings and other postings provided within the unincorporated area of Los Angeles County.

LASD PED utilizes the California Vehicle Code (CVC), the Los Angeles County Vehicle Code (LACoVC), and other parking ordinances applicable to Los Angeles County.

LASD PED serves and patrols all the unincorporated areas of Los Angeles County to improve parking.

LASD PED serves and patrols all 5 Supervisorial Districts serving over 1 million people and over 300,000 households.



LASD PED now serves the county 24 hours per day / 7 days per week.

LASD PED patrols hundreds of streets and thousands of miles of street sweeper routes averaging over 32,400 patrol miles per month.

LASD PED, on an average month...

- Issues over 24,000 parking citations.
- Issues over 1,800 "Red Tags" / 72-hour warnings
- Removes over 150 abandoned vehicles clearing the public right-of-way.
- Recovers over 130 stolen vehicles.
- Answers over 500 service calls from station dispatch (calls from citizens).
- Service Call response time: 30-minute avg.
- Patrols over 2,600 square miles of the unincorporated area of Los Angeles County
- Patrols over 3,200 miles of roadways within the unincorporated areas of L.A. County

FUNCTION of PED

LASD PED serves the unincorporated areas of Los Angeles County by providing the following services:

- Enforce parking violations under the California Vehicle Code & Los Angeles County Vehicle Code
- Street sweeping enforcement.
- Vehicle towing.
- Ensure adherence to local parking ordinances.

VITAL PARKING CONTROL OFFICER TRAINING:

- Mobile Digital Computer (MDC) Certification (on-board vehicle computer)
- Radio Use and Communication Skills (portable & vehicle)
- OC Spray Training (Pepper spray)
- Emergency Vehicle Operations Center Training (EVOC)
- Tactical Communications & Crisis Intervention Training
- DMV Registration & Disabled Parking Awareness Training
- Criminal Justice Information Services Certification (FBI approved in handling sensitive criminal justice information)

TOP CITATIONS TO BE AWARE OF:

- 1. **Street Sweeping** (PED does not follow the sweeper)
- **Failure to Obey Signs** (i.e. NO PARKING)
- 3. Failure to Obey Markings (i.e. RED CURB)
- 4. **Double Parking** (for Vehicles parked side by side)
- **Blocking Fire Hydrant** (parked within 15 feet)
- 6. **Unregistered Vehicle** (Expired plus 3 months)
- 7. **Parking in Alley** (CA law No signs necessary)
- Parking on Sidewalk (blocking pedestrian access)
- **Blocking Driveway** (parked w/in any portion of apron)
- 10. Parking 18" from curb (tires must be w/in 18" of curb)

RV CONCERNS / "Unhoused"

When an occupied vehicle is encountered, PED can issue a citation or a red tag warning (72 hour notice to move vehicle), however, PED cannot remove the vehicle or RV if it is occupied.



Our Sheriff's Department Homeless Outreach Services Team (HOST) will be notified and will take over. Only Deputy personnel are allowed to impound an occupied RV or vehicle. PED will work closely with the Homeless Operations Service Team (H.O.S.T.) to ensure the person(s) living inside the vehicle receive the proper assistance.

"CONTACT US" PORTAL

PED has created a public portal email notification system. Each station has its own email address as shown under the "16 Sheriff's Stations". The citizen submits a request for service, informs PED of a vehicle in violation or a vehicle in need of a warning notification (Red Tag), or they may ask for citation assistance.

- PED receives over 200 emails per month
- PED assigns each email to our officers in the field to expedite your request as quickly as possible.
- PED handles each email within 24 hours.

PED EMAIL SPECIAL NOTE:

FOR IMMEDIATE ASSISTANCE such as blocking a driveway, blocking a fire hydrant, double parking, etc. please call your local station and ask for an officer to be sent to address the parking violation at the location.



ADMINISTRATION SERVICES

At PED Headquarters, the administrative staff oversees all operations concerning our Parking Enforcement Officers as well as the needs of the citizens within the unincorporated areas of Los Angeles County.

For other parking-related issues, such as a citation inquiry, call the PED main line, and we will answer your questions or direct your parking-related issue to the appropriate staff in the office or in the field.
