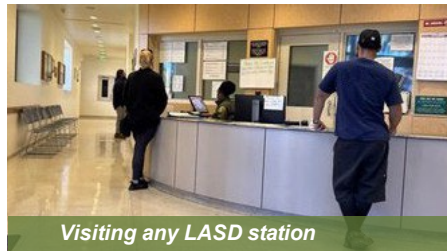
How Do I File a Complaint or Submit a Commendation with the Los Angeles County Sheriff's Department (LASD)?

You can file a complaint or submit a commendation through any of the following methods:

Online, by Phone, In-Person, or by Mail: File a complaint or submit a commendation by using the online form at www.lasd.org (in the "Contact Us" heading), calling at 1-800-698-TALK (8255), visiting any LASD station in-person, or sending the form by mail. Station addresses can be found at <https://lasd.org/stations>. All LASD webpages may be viewed in numerous languages by choosing a language option at the top right of the page.

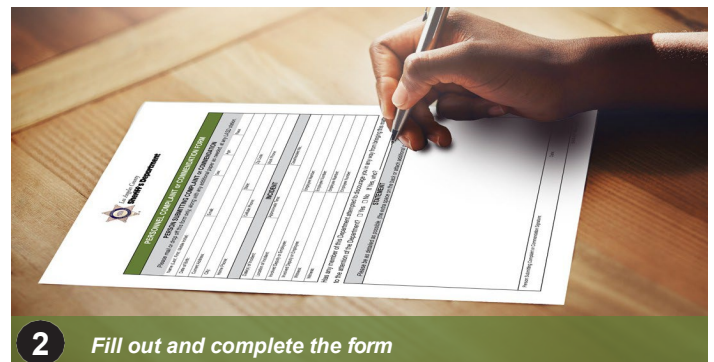
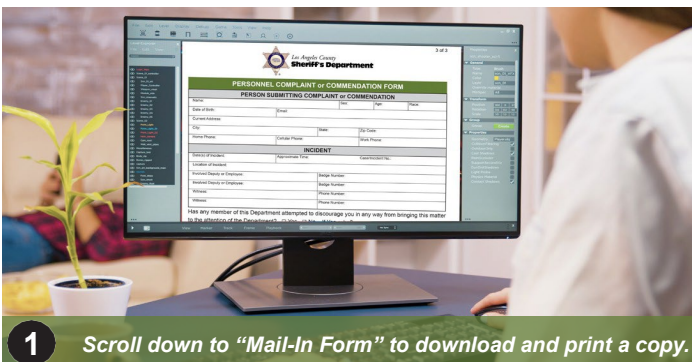

Mail-in Form: Use the form attached and mail it to the appropriate LASD station. You can also obtain a mail-in complaint or commendation forms by visiting the front desk of any LASD station, or visiting <https://lasd.org/file-a-complaint/> or <https://lasd.org/file-a-commendation> and scrolling down to the "Mail-In Form" tile to download and print a copy. Once you complete the form, mail it to the specific station address. A list of stations and their mailing addresses can be found at <https://lasd.org/stations>. Steps for Submitting Complaint or Commendation by Mail:





3 Put the completed form into an envelope.
Please attach postage.



4 Mail to the specific station address.
Do not forget to attach postage to the envelope.

Note: You may submit your complaint or commendation in your native language. LASD accepts all complaints, including **anonymous** complaints and those submitted by third parties. While the attached form requests specific information, you may still file your form if you are not aware of all the information. However, the more you can provide can assist in performing a thorough and complete investigation.

What Happens After I File a Complaint?

- 1. Investigation & Evidence Collection:** An investigator is assigned, an acknowledgment letter with a sequential number will be mailed to the reporting party, and the investigation will begin. The investigator will gather statements, evidence, and other relevant information.
- 2. Review & Notification:** The Unit Commander will review the investigation findings to determine whether the complaint is substantiated. Investigations may be conducted by the Internal Criminal Investigations Bureau (ICIB) for criminal allegations, the Internal Affairs Bureau (IAB) for administrative policy violations, or at the Unit level. Once the investigation is complete, you will be notified of the outcome by mail.

What Happens After I Submit a Commendation?

- 1. Receipt & Documentation:** Commendation is received, documented, and shared with the employee and their supervisor.
- 2. Personnel File & Acknowledgement:** A copy is placed in the employee's personnel file, and a letter acknowledging the feedback is sent to the reporting party.
