PREA Allegation Alerts

DEFINITIONS

Substantiated Allegation*

an allegation that was investigated and determined to have occurred

Unsubstantiated Allegation *

An allegation that was investigated and insufficient evidence was obtained to determine if the allegation did or did not occur

Unfounded Allegation*

an allegation that was investigated and proven to not have occurred

Sexual Abuse*

Any of the following acts, if the victim does not consent, is coerced into such act by overt or implied threats of violence, or is unable to consent

or refuse:

- Sexual contact
- Penetration of the anal or genital opening of another person, however slight, by a hand, finger, object, or other instrument; and
- Any other intentional touching
- Any attempt, threat, or request to engage in sexual activities
- Any display by a staff member, contractor, or volunteer of his or her uncovered genitalia, buttocks, or breast in the presence of an inmate, detainee, or resident, and
- Voyeurism by a staff member, contractor, or volunteer

Sexual Harassment *

- Repeated and unwelcome sexual advances, requests for sexual favors, or verbal comments, gestures, or actions of a derogatory or offensive sexual nature by one inmate directed toward another
- Repeated verbal comments or gestures of a sexual nature to an inmate, detainee, or resident by a staff member, contractor, or volunteer, including demeaning references to gender, sexually suggestive or derogatory comments about body or clothing, or obscene language or gestures
